RELEASE OF LIABILITY

I wish to participate in these activities knowing they are dangerous. I accept and assume all the risks of the injury (including death) to myself or my property.

In exchange for being permitted to participate in these activities, I release and agree not to make or bring any claim of any kind against Woodbrook Hunt Club, or it's masters, officers, directors, members, employees, or guests or any land owners, including the U.S.A/U.S. Army, Jt. Base Lewis-McChord, or other persons making property available for Woodbrook Hunt Club, for any injury (including death), or any damage to my property whether from negligence or not, or any other cause, arising out of my participation in these dangerous horseback riding, foxhunting or related activities; and I also agree if anyone makes any claims because of any injury to myself(including death), or for any damage to my property, I will keep all those released by this agreement free of any damages or costs because of those claims.
